



## COVID-19 ASSISTANCE FOR ALBERTA SMALL BUSINESSES

### CANADA EMERGENCY WAGE SUBSIDY (CEWS)

The CEWS program provides a subsidy of up to 75% of employee's wages, up to **\$847** per week from March 15, 2020 to October 23, 2021. Eligible employers include businesses who have suffered a drop of gross revenues during the COVID-19 pandemic. The base CEWS subsidy is calculated based on the actual revenue decline % in excess of the minimum required (max. 50%) x base rate factor. A revenue decline of **at least 10%** for the periods 18 to 21 is required. Where the current period revenue decline percentage is less than the preceding month, you are deemed to have a revenue decline % equal to the preceding month. For more info on CEWS click [here](#).

### CANADA EMERGENCY RENT SUBSIDY (CERS)

The CERS is a program that replaced the Canada Emergency Commercial Rent Assistance ("CECRA") program. This rent subsidy provides direct support of up to 65% of eligible expenses to qualifying renters and property owners that have experienced a decrease in revenue from Sept 27, 2020 until Oct 23, 2021. The calculation of revenues, base subsidy rate and qualifying reference periods will be determined in the same manner as the CEWS. Click [here](#) for more information.

Eligible expenses include commercial rent, property taxes, property insurance, and mortgage interest paid to arm's length parties under agreements entered into before Oct 9, 2020, up to **\$75,000** per location and subject to an overall cap of **\$300,000** (\$1m for THRP or HHBRP programs) that would be shared among affiliated entities.

**Lockdown Support** - A top-up of 25% is available for entities that temporarily shut-down or significantly limit their activities due to a mandatory health order.

\*\*Under the general method, periods 14 onwards the prior period reference month is in 2019 (pre-pandemic).

### CANADA RECOVERY HIRING PROGRAM (CRHP)

The CRHP is a hiring subsidy program that provides eligible employers with a subsidy of up to 50% of the **incremental** remuneration paid to eligible employees in respect of claim periods June 6, 2021 to May 7, 2022. The calculation of revenues, eligible employers/employees, qualifying reference periods, and application deadlines will be determined in a similar manner as the CEWS. However, a for-profit corporation would only be eligible for CRHP if it is a CCPC and furloughed employees are not eligible. The higher of the CEWS or CRHP may be claimed for a period, but not both. A revenue decline of **at least 10%** for the period is required. For more info click [here](#).

The subsidy is calculated based on the incremental remuneration x hiring subsidy rate for that 4-week period. Incremental remuneration is determined by comparing remuneration paid with respect to the qualifying period to the base period (March 14 to April 10, 2021). The hiring subsidy rates for the following periods are as follows:

June 6 to August 28	50%	September 26 to October 23	30%
August 29 to September 25	40%	October 24 to May 7, 2022	50%

### Tourism and Hospitality Recovery Program (THRP)

This is an extension of CEWS and CERS up to May 7, 2022 for hotels, restaurants, bars, festivals, travel agencies, tour operators, convention centres, convention and trade show organizers, and others. To qualify the business has to have had an average revenue decline of **at least 40%** for the first 13 CEWS periods (excluding period 10 or 11 which were based on the same month) and 40% for the claim period month. For period 22 to 26 the subsidy rate is equal to the revenue decline to a maximum of 75% (i.e. a 60% revenue decline in period 22 would result in a 60% subsidy rate). For periods 27 to 28 the rates drop in half. Click [here](#) for more information.

### Hardest-Hit Business Recovery Program (HHBRP)

This is an extension of the CEWS and CERS up to May 7, 2022 for hard hit businesses that do not qualify for the THRP. Eligible businesses are those that have experienced **at least 50%** revenue decline over the first 13 CEWS periods (excluding period 10 or 11 which were based on the same month) and a 50% decline for the claim period month. The subsidy rates will be much lower under this program. It is formula based and the formula is 10% + (revenue decline - 50%) x 1.6 for claim periods 22 to 26. Under this formula for period 22 a 60% revenue decline results in a 26% subsidy and a 75% decline results in the maximum 50% subsidy. Rates drop in half for periods 27 & 28. ### Local Lockdown Program (LLP)

Eligible organizations subject to a qualifying public health restriction would be eligible for subsidy rates as calculated under the THRP regardless of sector and would only require a current-month decline. The government expanded this program to include entities subject to 50% capacity-limiting restrictions and reduced the revenue decline threshold to 25% for claim periods 24, 25 and 26. ### OTHER PROGRAMS

**Canada Emergency Business Account (CEBA)** - Closed on June 30, 2021 Interest-free loans up to **\$60,000** to eligible borrowers, of which up to \$20,000 of the loan could be forgiven where the loan is repaid by Dec 31, 2023. Click [here](#).

**Highly Affected Sectors Credit Availability Program (HASCAP)** - BDC guaranteed loans up to **\$1m** to eligible borrowers available until March 31, 2022. Click [here](#).

**Tourism Levy Abatement** - operators with a 40% net revenue decline may qualify for abatement for the period Oct 1, 2021 to Mar 31, 2022. Click [here](#).
